


### **FAO's Four betters**

# The Challenge

SFS delivers food security and nutrition for all in such a way that the economic, social and environmental bases to generate food security and nutrition for future generations are not compromised





#### HOW A FOOD SYSTEMS APPROACH CAN CONTRIBUTE TO FAO'S CORE ACTIVITY AREA

- AREA 1. Putting data within reach to support the transition to sustainable food systems
- AREA 2. Promoting evidence-based **policy** making and policy alignment
- AREA 3. Bolstering **public-private** collaboration in sustainable food systems development
- AREA 4. Facilitating local knowledge-building and knowledge-sharing
- AREA 5. Supporting countries in preventing and mitigating risks



#### NERC 37 Declaration 5 March 2024

- We note with concern the worsening challenges posed by climate change, water scarcity, soil erosion, and fluctuating climate patterns because of declining agricultural productivity.
- We acknowledge the need and increased focus on accelerating the transformation of our region's agricultural and food systems so that they become more efficient, inclusive, resilient and sustainable; It addresses the present and future challenges facing the region and accelerates progress towards achieving the sustainable development goals.
- We stress the importance and need to develop analytical systems for monitoring and reporting on food security and for making relevant policies based on evidence.



#### NERC 37 Declaration 5 March 2024

- We pledge to work towards transforming our agricultural and food systems through the adoption of comprehensive, multi-sectoral and multi-stakeholder approaches with the participation of agricultural and food system actors and their representatives, civil society, academia and the private sector;
- We pledge to pursue integrated strategies for comprehensive rural transformation to promote decent rural employment opportunities, especially for youth and women, through regional development approaches and in view of the priorities of the Regional Action Plan for the United Nations Decade of Family Farming;
